


Description: During the quarter there was a great underperformance in the number of registered OVC for UThukela District. Immediately after picking this up the District brought this to the attention of the service offices and they were urged to take this seriously and communicate this with organizations under their respective offices.

The district office then decided to have a meeting on the 18th July 2014 on Service Delivery where all service offices and management from Community Care Centres were invited so as to address this. The number of children to be registered will increase during the quarter ending in September 2014 as the Community Care Centres report on a monthly basis and the meeting held is proving to be a success as it is evident from the reports received during the month of July and August that the number of OVC registered is increasing. Also there are 4 more Community Care Centres under the Umtshezi and Imbabazane Municipalities rendering services to OVC and these have been funded by the DSD thus extending reach. Lastly, CCGs under Uthukela are attending the Intergrated Community Care Givers Foundation Course since the 21July 2014 and this will definitely improve service delivery.


Male Medical Circumcision

Achievements: MMC performance has improved by 201 compared to the same quarter the previous year, attributable to MMC Camps being now conducted monthly in prisons and in 6 tribal courts. Challenges: MMC target not achieved because of the low uptake during holidays, ineffective MMC coordination, inadequate and incomplete MMC roving teams.

Action Plan: To improve involvement of leadership in MMC advocacy. To facilitate community dialogues and awareness campaigns. To conduct more camps in FET's, clinics, tribal courts. To motivate for more staffing in MMC roving teams.

Need to strengthen training to leadership.









Comments: when comparing two quarter (Q1 2013 and Q1 2014) there is an increase of 1950 in a number of new HIV tests carried out, through support of NGO partners i.e. Duduza Center, HST and LGBTI.

Implementation of opt out HIV testing approach in facilities and in outreach events has contributed as well.






TB AND HIV CO - INFECTION

Comments: TB Screening tool has been included as part of HCT records to improve TB screening.









Condom Distribution

Comments: Target exceeded because of the availability of condom distributors.

Challenge: Inconsistent availability of femodoms.

Plan: Order more, so as to compensate for the times where there is inadequate femodoms.







Prevention of Exposure to transmission from occupational exposure and sexual violence

2.	Children under 12 years sexually assaulted rate	126	70	113

Comment: Sexual assaults cases are a challenge beyond DOH capacity and control therefore. Intervention need OSS approach for SAPS to be cooperative and be able to give all the data as this is not a true reflection of the cases. Other cases got reported to SAPS however not included in the report.



- Comments: Pregnant women on ARV prophylaxis, when prophylaxis is discontinued they are counted as loss to follow up because there is no outcome for patients on Prophylaxis.
- There is a decrease in clients deregistered due to follow up because of improvement in recording and data management.
