Comments: Figures though they are increasing from Q1-Q3, Q3 indicates higher figure this is due to having events during November and December such as 16 days of Activism and the world AIDS day which also has some build up events where such information and awareness is disseminated. Also municipalities have many events i.e. Municipal events, cultural events. With indicator number 2, younger people 15-24 Q1 there was underreporting but in Q3 we also had few numbers because this age includes children at school and children in higher learning and during this time they were writing exams. The District therefore needs to design a plan on how to fast track the process of meeting the target.

Comments: We do have integrated resources in the District through Department of Education (My life, My Future Campaign), Government Departments (Child Protection week, 16 days of Activism, etc.) and Civil Societies (Girls and Boys talk, Life Skills, etc.); though such resources are taken to schools, figures still remain high. The District has started community dialogues whereby it appeared that some of the parents are poverty stricken and therefore are unable to fend for their children, thus exposing them to financial vulnerability. The parents also do not support the programmes which are in place. The plan therefore is to continue with community dialogues as well as advocacy campaigns on Schools Senior Management Teams.

#### **Comments:**

 Babies who tested positive at 18 months were found to be mixed fed and some had mothers who had tested HIV negative during pregnancy and became positive while breastfeeding. Few pregnant women who visited the clinics before 20 weeks of their pregnancy in December

TB cases still high. MDR-TB cases also remaining high. Massive TB awareness campaigns to be conducted in areas with high incidents. Training of health care workers on management of TB is continuing.

There is a shortage of service providers to distribute condoms in grey areas of the district. The district has distributed 4, 869, 716 so far and is above the total distributed in 2012/13, however this is still below target. Health facilities and CCGs have been given targets to distribute in order to meet the target.
