- ▶ Peaceful march against GBV, TB awareness campaign, march against cancer, World AIDS day celebration and other various programmes were held within the district towards achieving different goals. Goal 1, Prevention and Goal 2 .
- ▶ DOE programmes like My Life My Future (MLMF) Campaigns positively affected the district pass rate.
- ▶ The district achieved 80.6% matric pass rate for the class of 2020, ranked the 3rd out of 12 Districts, as of 2018 which was 78.10 ranked number 4 and 2019 which was 80,60. There is a huge improvement noticeable.
- ▶ The District is doing well on condom distribution
