- Secretariat submitted Request for Funding (RFF) for iLembe District and it was declined by CCM because the District is already being supported by PEPFAR on Sex Worker Programme.
- Amajuba District has not held a District AIDS Council (DAC) meeting for the financial year 2020/21: DAC Meeting not held yet at Amajuba District, however DAC Strengthening was done for the District on the 21-23 September 2021.
- Impact of economic relief given to women to fight GBV. Office on the Status of Women and Children coordinates GBVF in the Province. A full report to be presented in the PCA of 18 May 2022.

# **Agenda Item 2.5 MECs and District Mayors Inputs:**

Monitoring malnutrition should be revived: Districts reported on data on malnutrition. Severe Acute Malnutrition inpatient under 5 years – Quarter 3 2021/22 =447 and Severe Acute Malnutrition death under 5 years - Quarter 3 2021/22 = 422

Pregnancy in Young girls 10-14 years is a concern: OTP leading the response assisted by DSD, DOH, Community Safety, SAPS and NPA. Key finding reports obtained from Departments: NPA – will put unresolved cases back into the court roll; Education – will encourage young girls to go back to school through the back to school campaign; DSD – will enrol young girls to parenting programmes; Health – will encourage young parents to vaccinate their children and consider taking up contraceptives. Office of the Premier – Office on the Status of Women and Children is monitoring progress for each Department on quarterly basis through GBV Technical Working Group. Some of the indicators collected for October-December 2021 are as follows:

- 1. Number of statutory rape case opened 45;
- 2. Number of girls who attended ANC-8130;
- 3. Number of convictions made-01 and
- 4. Number of arrests done 25

2.1 ICASA CLOSE- OUT REPORT AND SANAC PRIORITIES	SANAC was represented by Reverend Zwoitwaho Nevhutalu SANAC Executive Manager for Stakeholder Management and Campaigns. His presentation was entitled "SANAC National Updates" and discussed the following:  1. Development of Provincial Catch -Up Plans. 2. Development of the new NSP 2023-2028. 3. Global Fund Grant Update. 4. Development of the SANAC Multi-Sector Policy Framework for HIV, TB and STIs. 5. South African Local Government Association (SALGA) Portfolio Based Inductions for new Councilors 6. International AIDS Conference 2022  1. Development of Provincial Catch-Up Plans The development of the NSP 2023-2028 had been deferred and replaced with development of Provincial Catch Up Plans to revitalise the HIV, TB and STIs multi-sectoral programme. SANAC supported the development of Catch-Up plans and the process has been completed in all Provinces. SANAC has developed a dashboard to support the Provinces to actively monitor the Catch-Up plans. The PCA was requested to note update on PIP Catch-Up plans and to support the implementation of the KZN PIP Catch-Up Plan  2. Development of the new NSP 2023-2028 The development of the NSP 2023-2028 has commenced. This will be done concurrently with development of the Provincial Implementation plans. The new NSP will be launched World TB Day on March 2023. A high-level workshop was held in February 2022 to solicit inputs from and develop a blueprint with key opinion leaders in South Africa on HIV, STIs and TB to guide the development of the NSP 2023-2028 and came up with 11 emerging themes for the development of the new NSP. The PCA was requested to note timelines for development of NSP for HIV, TB and STIs 2023 – 2028	
	3. Global Fund Grant Update The Country had secured the Global fund allocation for 2022-2025. The revised allocation by the country and	

approved by the Global Fund was 536 766 626 United States dollars which is 8 773 128 442 ZAR at 16 Rands/Dollar exchange rate. A surge investment was prioritized for TB interventions, responding to the recent findings of South Africa's first TB prevalence survey which showed a TB burden about twice as high as was previously estimated.

The PCA was requested note the updates on the new Global Fund grant cycle in South Africa and the arrangements for the Province.

#### 4. Development of the SANAC Multi-Sector Policy Framework for HIV, TB and STI.

SANAC is developing a Multi-Sector Policy Framework to achieve standardization of all SANAC structures, to be approved by Cabinet. SANAC was also conducting a high-level review of the SANAC Procedural Guidelines as a backbone of the SANAC Multi-Sector Policy Framework. These will be thoroughly consulted with all SANAC stakeholders. SANAC will share with the provinces process outline.

The PCA was requested to note the development of a Multi-Sector Policy Framework and the high-level review of the SANAC Procedural Guidelines.

The PCA was further requested to support and participate in this process.

#### 5. SALGA Portfolio Based Inductions for new Councillors

SANAC was working with SALGA to develop Policy Position for the Strengthening of the Local Government HIV, TB, STI response. The aim of the position paper is to determine local government niche and clarify its role in response to HIV and AIDS within the intergovernmental and multi-sectoral approach. The first round of stakeholder consultations (internal) had been completed, a draft Policy Position developed and shared for external inputs.

SANAC was working with SALGA to prepare for the Portfolio Based Inductions for new Councillors. The objective of the inductions is to familiarise councillors in this term of local government with their portfolios and the attached roles and responsibilities. The inductions will target MMCs/Portfolio Councillors and E/Mayors.

The PCA was requested to note and support SALGA on the development of the SALGA Policy Position and to input into the draft Policy Position.

The PCA was further requested to note the SANAC/SALGA collaborated plan towards Portfolio Based Inductions and to urge the PCA to work closely with their provincial counterparts of SALGA.

#### 6. International AIDS Conference 2022

The 24th International AIDS Conference will be held in Montreal, Canada from 29 July 2022 to 2 August 2022. The theme is RE-ENGAGE AND FOLLOW THE SCIENCE. Focus will be on:

- 1. Defining future research agendas
- 2. Shift latest evidence to action, and
- 3. Chart a new consensus on overcoming the HIV epidemic as a threat to public health and individual well-being

The inter-ministerial committee has issued communication to the Premier on the conference and expectation of the province.

South African participation will be centrally coordinated by the SANAC Secretariat. Lessons from previous South Africa's participation in other International AIDS conferences such as Amsterdam 2020 will be taken into consideration.

The PCA was requested to note details of the upcoming 24<sup>th</sup> International AIDS Conference to take place in Montreal, Canada and to share the Province's plans for the Conference with SANAC.

#### Requests

- Free State, North West, Gauteng to have a study tour in KZN
- Request the acceptance and approved of the study tour by provinces
- The study tour to be addresses by the Premier himself
- The other Premiers will also visit the province

#### 2.2 DISCUSSIONS

- MEC Ms Nomagugu Simelane noted that 95-95 -95 had been adopted while in some cases the districts are still on 90-90:90
- Response-UNAIDS has moved to 95:95:95:so, the country needs to adopt that strategy and move on.
- Mayor Ngubane sent condolences to the Co-chair and applauded KZN province for having best practices and enable other districts to benchmark on.
- PEPFAR to be brought into the SANAC framework of monitoring and co-ordination
- MEC Ms P Nkonyeni -acknowledged that the country is receiving a huge allocation for GF and she enquired how much then is the allocation from PEPFAR
- Question: Is how these donated funds are monitored, can the PCA decide on other programmes to be funded e.g. Police stations to have victim friendly facilities
- Response -the funds are monitored CCM: GF ensures that funds are used as per allocation, those that are closer to the projects should be able to monitor them.
- Response-allocations are based on programmes funded for GF requests the deviation in writing and it will

#### need to be approved. The Premier ensured SANAC of the commitment by KZN PCA to those of excellence. Mrs Gugu Shabangu presented the Provincial Synthesis Report for Quarter 3 FY 2021/22. The report provides an 2.3 Q3 2021/22 **PROVINCIAL** overview of the status/progress on the implementation of interventions and programmes of the multi-sectoral SYNTHESIS, PEPFAR response to HIV, TB and STIs by stakeholders i.e. Government departments, Non-Governmental Organisations, Community Based Organisations and a Partners such as the Global Fund and PEPFAR. The report was outlined AND GLOBAL FUND REPORT as follows:

- 1. Mobilisation of Resources
- 2. Coordination, Leadership and Accountability
- 3. Prevention
- 4. Treatment, Care and Adherence Support
- 5. Reaching all Key and Vulnerable Populations

# 1. Mobilisation of Resources and Coordination, Leadership and Accountability (Goal 7 the NSP/PIP)

- The Global Fund and PEPFAR are the key funding partners supporting HIV, TB and STIs programmes in the Province. Global Fund 2021/22 funding-R 143 317 403,00. PEPFAR 2021/22 funding: R 1 399 471 121,44.
- 7 districts-uGu, King Cetshwayo, Zululand, eThekwini, uMgungundlovu, uThukela and Harry Gwala supported by through Global Fund and PEPFAR programmes.
- Two districts -Amajuba and uGu -did not have dedicated AIDS Coordinators.
- 4 districts-King Cetshwayo, uGu, uMgungundlovu and uThukela-reported no funding allocations for coordination of HIV, TB and STIs activities in 2021/22.

# 2. Coordination, Leadership and Accountability (Goal 6 the NSP/PIP)

- Amajuba, Zululand and uMzinyathi have not held any DAC meetings.
- 5 DAC meetings chaired by Mayors in 7 of the DAC meetings held. 4 DAC meetings co-chaired by District Civil Society.
- 354 stakeholders reached across all 11 districts with capacity building workshops as part of District AIDS Council Stakeholders Strengthening.

• 6 districts reached with orientations for Political Leaders on HIV, TB, STIs and GBV response in collaboration with COGTA- iLembe, Zululand, Amajuba, uMzinyathi, eThekwini and King Cetshwayo

#### 3. Prevention (Goal 1 of the NSP/PIP)

- HIV testing reduced by 8% in Q3 2021/22 as compared to 0,01% reduction for Q2 2021/22. Decrease in testing noted in 7 districts. HIV positivity remained below target for all districts.
- Male condoms distribution increase noted in uThukela and eThekwini. Generally, condom distribution remains low.
- Medical male circumcision affected by COVID-19 but gradual increase in numbers getting circumcised noted. No district however achieved targets.
- Under 5 years deaths continued to reduce quarter on quarter with Q3 recording a 15% decrease. Harry Gwala, uMkhanyakude and uThukela recording increased deaths for 2 consecutive quarters.
- Deliveries 10-14 years decreased by 17%. All districts-except iLembe, uMkhanyakude and uThukelarecorded reductions.
- Learner dropouts recorded in 2021 was 106054 as follows: Males- 54351 and Females- 51703
- Learner pregnancies reported 2021 was 800.
- Teenage pregnancy dialogues held in 7 districts-King Cetshwayo, uMkhanyakude, iLembe, uMzinyathi, Zululand, uMgungundlovu and eThekwini. A total of 700 participated in the dialogues across the 7 districts. Teenage Pregnancy Summit planned for August 2022

#### 4. Treatment, Care and Adherence Support (Goal 2 of the NSP/PIP)

- 7 districts-Harry Gwala, King Cetshwayo, uGu, uMgungundlovu, uMkhanyakude, uMzinyathi and Zululand with 90% and above of targeted PLHIV remaining on ART.
- Province commemorated 33rd WAD on 1 December 2021 in eThekwini. Event was led by the Premier Mr.
   S Zikalala. An estimated 600 people who were mainly youth attended). All districts except for King Cetshwayo and iLembe commemorated WAD 2021.
- 8 districts-eThekwini, uMzinyathi, iLembe, uThukela, uMgungundlovu, Amajuba, uMkhanyakude and uGu conducted Behavioral Change Campaigns (BCC). An estimated 1800 community members participated across the districts.
- Provincial World TB Day hosted on 24 March 2022 in uThukela district. MEC Ms Nomagugu Simelane and MEC Ms Nomusa Dube-Ncube led the commemoration. About 700 community members attended.

# 5. Reaching all Key and Vulnerable Populations (Goal 3 of the NSP/PIP)

- 83% (1764) of the targeted Adolescent Girls and Young Women (AGYW) using Pre-Exposure Prophylaxis (PrEp) and 92% (146) of targeted AGYW linked to care. 27% (16) of targeted Male Sexual Partners (MSP) linked to care. 65% (266) of the targeted Sex Workers using PrEP. 1257 People who Inject Drugs (PWID) in eThekwini and uMgungundlovu reached with a minimum package of services. 11% (282) of the targeted men who have Sex with Men (MSM) using PrEP.
- Revitalisation of uGu LGBTQIA+ sector done in November 2021.
- The girls' empowerment camp held in February 2022 in King Cetshwayo District. 50 AGYW from all the 5 local municipalities in the district participated in the camp. Adolescent and Young people (AYP) Champions placed in 4 districts -uThukela, uMgungundlovu, eThekwini and Zululand from October 2021. Youth summit held in November 2021. About 150 youth from across the province attended.
- PrEP indaba planned for May 2022

#### 6. Addressing the Social and Structural Drivers of HIV, TB and STIs( Goal 4 of the NSP/PIP

- Districts with highest number of Orphans and Vulnerable Children and Youth (OVCY) receiving psychosocial support services in Q3 1) uMkhanyakude; 2) eThekwini; 3) Zululand; and 4) King Cetshwayo.
- 5% increase in sexual assault cases seen at health facilities. 7 districts- Amajuba, eThekwini, Harry Gwala, iLembe, uMkhanyakude, uThukela and Zululand recording increased numbers.
- Children sexual assault cases increased by 6%. 6 districts- Amajuba, eThekwini, Harry Gwala, King Cetshwayo, uMzinyathi and uThukela recorded increases.

# 7. Human Rights (Goal 5 of the NSP/PIP).

- The Global Fund through AIDS Foundation of Africa supporting interventions on Human Rights. Implementation of Human Rights Interventions gradually picked up in 2021.
- The most frequent human rights violations reported were sexual and gender-based violence; right to health and; assault and violence. Key populations with most frequent human rights violations recorded were People living with HIV and Adolescent girls and young women

#### 8. Strengthening Strategic Information (Goal 8 of the NSP/PIP)

- Monitoring and Evaluation workshops and Mentorship conducted for District AIDS Councils and Local
- AIDS Councils Teams. 354 stakeholders reached across all 11 districts
- District Monitoring & Evaluation Task Teams revitalisation and establishment commenced.

# 2.4 Q3 &ANNUAL 2021/22 PROVINCIAL CIVIL SOCIETY REPORT

Mr S Zungu the Secretary of the Provincial Civil Society Forum presented the Civil Society report. The presentation outline was as follows

#### Below are the highlights:

#### 1. Provincial Civil Society Remarks

- Quarter three (October 2021- December 2021) had been one of the busiest quarters of 2021. Province
  hosted the Women Now Summit, the ICASA, the Women's month, 16 days of activism; the World AIDS
  Day and the International Day of Persons with Disabilities.
- Gender-based violence and femicide cases continued to increase. Latest crime statistics showed KZN was
  the only province to record an increase in crimes against women. Inanda and uMlazi continued to be in the
  lead police stations recording the highest increase in rape and sexual offences.

#### 2. Coordination and Governance

Civil Society participated in the following:

- District Behaviour Change campaigns (BCCs) in all the 8 districts. Civil Society noted that King Cetshwayo, Harry Gwala and Zululand districts were outstanding in terms of holding BCCs.
- Provincial AID Councils Strengthening workshops in all 11 districts.
- Global Fund Roadshows to present new cycle for Global Funding 2022-20225 in January 2022 in 5 districts-eThekwini, uMgungundlovu, uGu, Zululand and King Cetshwayo.
- Woman Now conference in December 2021. Issues affecting women living with HIV were discussed including stigma reduction strategies. ICASA held in December 2021. The Youth sector was instrumental in organising the KZN Youth Village. The Youth village provided a vibrant, interactive, empowering and active safe space for youth engagement and dialogues.
- Provincial Traditional Men's Parliament held in November 2021 and led by MEC DSD, KZN Deputy Speaker, and KZN Traditional Leaders EXCO. The parliament discussed GBV&F, HAST and other social

ills.

- Launch of 16 Days of Activism against GBV & F in November 2021.
- The Provincial and District World AIDS Day 2022 commemorations. World TB Build up events held in different districts and the main event in uThukela District in March 2022.

The following sector activities took place.

- LGTBQI held a stakeholder meeting in February 2022 to discuss progress on resolutions taken during the KZN LGTBIQ summit and develop KZN LGTBI implementation plan.
- PLHIV Sector District revitalization workshops conducted in March 2022 for Zululand, uMkhanyakude, uMzinyathi and uMgungundlovu.
- Elections held for Provincial Sex Worker Sector and Research Sector in February 2022. New structures in place
- PLHIV Sector led teenage pregnancy dialogues held in 7 Districts.
- KZN Youth Summit in November 2021.

#### 3. Opportunities in Programming

- Launching outstanding sectors giving priority to Children and Persons with Disabilities sectors
- Continued PCA strengthening with focusing on Resource Mobilization, Coordination, Leadership and Accountability

#### 4. Challenges in Programming

Civil Society noted the lack of resources for Sectors and the Civil Society Forums. For example, Sectors do not have access to office space or transport to facilitate implementation of their activities.

She presented the report based on the 6 pillars of the GBV&F strategic plan as follows:  1. Pillar 1: Accountability, Coordination and Leadership 2. Pillar 2: Prevention and Rebuilding Social Cohesion 3. Pillar 3: Justice Safety and Protection 4. Pillar 4: Response, Care, Support and Healing 5. Pillar 5: Economic Power 6. Pillar 6: Research and Information Management  1. Pillar 1: Accountability, Coordination and Leadership • eThekwini was the only district with a functional District Gender Machinery. • The Provincial Gender Machinery met in October 2021. The meeting discussed the Women Empowerment Programmes, and GBVF programmes implemented during 16 days of Activism for no violence against women and children. • In December 2021, the Office of the Premier coordinated an orientation workshop for District GBVF Rapid Response teams.  2. Pillar 2: Prevention and Rebuilding Social Cohesion • 5 Districts have sexual harassment polices-these were uGu, eThekwini, King Cetshwayo, iLembe and Zululand. eThekwini is the only district that has implemented its sexual harassment policy. • The DOH, COGTA, Treasury Public Works, Sport and Recreation, DSD and the OTP were the only departments that were fully implementing the Sexual harassment policy in workplace. • About 4330 people reached with GBVF prevention programmes. Just above 1500 men had been reached with programmes to shift behaviour in men. 651 people reached with programmes on prevention of bullying in schools. • 651 Community Development Workers trained on GBVF prevention. 686 people reached with capacity building on sports and recreation.	

#### 3. Pillar 3: Justice Safety and Protection

- 7653 GBV cases reported to police, 34% of which were in eThekwini.
- A total of 8055 sexual assault cases seen in public health facilities cases for April 2021-December 2021 of which. 2466 of these were for children under 12 years. 3094 sexual assault cases reporting in public health facilities after 72 hours.
- 314 Domestic violence cases reported. 44% of these reported in eThekwini.
- 43 Child abuse cases reported. Mostly were from eThekwini Metro, followed by King Cetshwayo, iLembe and uMkhanyakude.

## 4. Pillar 4: Response, Care, Support and Healing

• Department of Social Development provided psychosocial support services to 7 918 women. 83702 beneficiaries reached through Social Relief of Distress programme in October to December 2021.

#### 5. Pillar 5: Economic Power

- 54 Women contractors from Zululand district benefitted from the Women in Construction Symposium organised by Department of Public Works.
- 55 537 women reached through economic empowerment programmes.
- A training conducted for women owned contractors in uGu District courtesy of the Department of Public Works (both National and Provincial) in collaboration with National Home Builders Registration Council.
- 367 women benefited in housing
- Department of Human Settlement reported 337 work opportunities for women through 119 projects.
- 2177 Land and house titles or leases provided in the names of women.
- COGTA reported 36 812 jobs created for women.

## 6. Pillar 6: Research and Information Management

• The province held a colloquium or GBV focusing on "why men are angry."

# 3.2 DEPARTMENT OF BASIC EDUCATION POLICY ON THE

The presentation was made by Mrs TPJ Khoza Chief Director: Social Enrichment Programmes in the Department of Education. She discussed the following:

# PREVENTION AND MANAGEMENT OF LEARNER PREGNANCY IN SCHOOLS

#### 1. Background.

The Department of Basic Education (DBE) Policy was developed to address the conundrum of learner pregnancy in South African schools. In terms of data, she indicated that 800 learners fell pregnant in the KZN province in the last financial year 200/21.

#### 2. Policy Goals.

- To reduce the incidence of learner pregnancy through the provision of quality Comprehensive Sexuality Education (CSE) and access to adolescent and youth friendly Sexual and Reproductive Health (SRH) services.
- To promote the constitutional right of learners to basic education by ensuring they are not excluded from schools as a result of pregnancy and childbirth.
- To provide a supportive environment for them to complete their basic education.

#### 3. Scope of Application

The policy applies to the following:

- Learners
- Educators
- Principals
- School management teams
- School governing bodies
- School based support teams
- DBE staff and
- Other co-curricular service providers and NGOs that are directly involved in the prevention and management of learner pregnancies in the basic education system at all public and independent schools in the Republic of South Africa.

# 4. Policy Provisions

The policy provisions and corresponding objectives are shown on the table below.

PROVISION	OBJECTIVE
Enabling environment	To ensure that schools are safe, free of stigma and provide a non-discriminatory environment for pregnant learners, guaranteeing them the right to education during their pregnancy and, following childbirth, facilitating their re-entry into schools.
Prevention	To ensure that learners have access to SRH information and skills, accurate knowledge about delayed sexual debut, abstinence and contraception, and information about the role of gender and power in relationships, in order to make informed life choices and help protect them from unintended pregnancy.
Care counselling and support for pregnant learners	To ensure that schools provide a positive and supportive environment where all pregnant learners can access professional advice, information, referrals, treatment, care, counselling and support.
Impact mitigation	To mitigate the impact of pregnancy on the affected learners through the provision of a systemic, sustainable, structured, safe and empowering environment.
Policy management and implementation	To put sustainable management structures and strategies in place at all levels of the basic education system to ensure implementation of this Policy and to monitor and report its progress and success over the life of the Policy

# 5. Strategies for the Prevention and Management of learner pregnancy in schools.
