Bottle neck	Root cause	Remedial plans
25% of patients not initiated during third quarter 2021	Poor tracing of patients with cormobids and patients taken bloods for investigations were delayed on waiting for ART	<p>Advise facilities to actively seek the clients who tested HIV positive and were not initiated over the previous weeks, through a call back to care system of phone calls and contact visits.</p> <p>Advise facilities to market ART treatment as prevention: Early treatment can increase the likelihood of someone achieving viral load suppression and reduce HIV transmission</p>
