Quarter 4 (Jan –March 2021/22) Action Item Update

New positive cases	 Low HIV positivity yield 1,7% - 6%. Targeted testing not adequately done. Inadequate implementation of targeted Index community testing including testing of contacts within period of 5 days. Inadequate partner elicitation, as clients are not ready to give their contacts. 	 Conduct community targeted testing in areas of high prevalence, including weekends and public holidays plus flexible working hours. Daily/Weekly monitoring and verification of data. Involve traditional leaders, traditional Health practitioners, political leaders, isibaya samadoda, ikhosomba lamajita and religious fraternity through OSS to influence communities especially men and young people, for HTS uptake. 	 All men visiting the health facilities, are fast tracked and offered all the services. Targeted testing mostly done in fixed clinics but at a low scale. Mobile clinics service layering with other partners to increase access. Men are tested in the district conducted gatherings like Isibaya Samadoda, VMMC, etc. over 7 days in a week. Integrated door to door community services through ward based outreach teams, are conducted per each facility/Local.
